

TRAXXIS RUBBER TRACK Agricultural Usage

Effective Date: Product produced on or after 6th January 2017

Eligibility

Original owner of new TRAXXIS rubber tracks that were purchased through an authorized TRAXXIS™ aftermarket dealer or directly from Sly Europe Ltd, Sly Agri Ltd or Sly France SAS.

Coverage

TRAXXIS agricultural tracks are warranted, from date of purchase to 48 months or 4000 hours for friction drive tracks, 48 months or 2000 hours for positive drive tractor tracks, and 2 years or 1000 hours for positive drive combine tracks, as shown on the Customer Participation Charts, against defects in materials or workmanship. An TRAXXIS track that becomes un-serviceable as a result of a defect in materials or workmanship, as determined by manufacturer, will be replaced, or allowance will be given towards purchase of replacement TRAXXIS track, at manufacturer's choice.

Excluded from Coverage

- Track manufactured more than 60 months prior to warranty request.
- Usage in non-agricultural (commercial construction, scraper) applications.
- Usage with cast slotted drivewheels (CSD).
- Rapid wear or damage caused by extended transport operations.
- Remanufactured track.
- Failure resulting from abuse, misuse, negligence, alteration, accident, field or road hazard or stubble damage, overload, mismatching of adjacent tracks, misapplication, use of non-authorized/non-standard undercarriage components, or poor mechanical condition, maintenance or adjustment.
- Cosmetic defects, such as surface cracks, splits and other superficial distress that may impact track appearance but does not render the track unusable or measurably diminish overall life.
- Usage, installation, or adjustment which manufacturer judges improper.

Owner Obligations

- Giving notice of failure within applicable warranty period and providing valid proof of purchase.
- Transportation cost to warranty service location.
- Removal and Installation costs and taxes.
- Freight charges if applicable.
- Undercarriage components properly maintained and adjusted.

Prorated Replacement

Months of service is defined as the time from track sale date to the acceptance of warranty claim from the completed warranty claim form. To determine the replacement price, the appropriate pro rata percentage from the customer participation chart is multiplied by the current list price.

Track Warranty Period

Track replaced due to a defect in materials and workmanship during the original track warranty period, and customer participation is less than or equal to 50%, the replacement track warranty period is limited to the remainder of the original track warranty period. Otherwise, the replacement track will carry a full new track warranty.

Other Conditions

Appropriate taxes, mounting, or other service charges may be added by dealer to the total customer replacement cost. Manufacturer may recall any warranty track, require disabling of the warranty track to preclude further use, or require evidence replacement track was sourced from Manufacturer, as a condition for claim reimbursement.
